HOW TO ORDER TICKETS

All shows scheduled are subject to change, modification or substitution. No Refunds or Exchanges.

1. Fill out the Event Sheet in full (Wynmoor Address only). Enclose both Event Sheet and check (payable to WCC) in envelope. Be sure check contains your Wynmoor address.
2. During the months of October through May, four tickets for each show may be purchased on one Event Sheet per apartment. Only one Event Sheet per envelope please. NOTE: A resident who is on the Legally Blind list may order four tickets for each show; however, only two of those tickets for each show will be in the Legally Blind sections of the Theatre. SEATS IN THE LEGALLY BLIND SECTIONS ARE FOR WYNMOOR RESIDENTS ONLY.
3. For the New Year's Eve Dance you may order tickets for an entire table (10 seats) including guests. A separate Event Sheet is required for the New Year's Eve Dance
4. On Monday, October 9, 2017 at 8:05 AM. PLEASE DROP YOUR ENVELOPE INTO THE SLOT NEXT TO BOX OFFICE (one envelope per resident).*
5. No orders will be accepted before October 9, 2017. Deadline for DECEMBER orders is Monday, October 23, 2017 at 4PM.

ALL TICKETS ARE MAILED TO YOUR WYNMOOR ADDRESS ONLY VIA FIRST CLASS MAIL. TICKETS ARE ISSUED ON FIRST-COME, FIRST-SERVED BASIS. In case of error, please bring your Event Sheet and Tickets to the Box Office. DECEMBER EVENT SHEETS will be available outside the Theatre on Monday, September 25, 2017.

TO PURCHASE TICKETS IN PERSON AT THE BOX OFFICE



1. December tickets may be purchased at the Box Office starting Monday, November 6, 2017.
2. Bring your own Wynmoor ID card and check or cash in the EXACT AMOUNT ONLY.
3. You may not purchase another resident's tickets with his/her ID card.
4. Legally blind tickets may be purchased by all residents ONE WEEK BEFORE SHOW, if available. No more than two Legally Blind tickets permitted per resident. SEATS IN THE LEGALLY BLIND SECTIONS ARE FOR WYNMOOR RESIDENTS ONLY.

- ★ Proper attire required after 6:00 PM for shows and dances - NO SHORTS (OK for movies).
- ★ Please be on time.
- ★ CHILDREN younger than 15 are not allowed in Theatre.
